RAY OF SUNSHINE CONTEST

CONTEST RULES (the "Rules")

The "RAY OF SUNSHINE CONTEST" (the "Contest") is organized by Transat Tours Canada Inc. operating as Transat (the "Organizer"). The Contest starts on January 11th, 2016 at 08:00 a.m. Montreal time (the "Contest Opening Date"), and ends February 6, 2016, at 03:59 p.m. Montreal time (the "Contest Closing Date", which period shall be reffered to as the "Contest Period").

1. ELIGIBILITY

PRIZE CLAIM
